Please Note

The event will be classified Category "C" in accordance with RRS appendix 1. The races will be governed by the Racing Rules of Sailing 2009 – 2012, subsequent amendments thereto, the rules of the Lark Class Owners Association and the event supplementary sailing instructions. Competitors should note that Northampton Sailing Club implements the RYA Racing Charter and that they will be required to undertake to sail in compliance with the Charter, which can be found at the front of the RYA rule book.

Conditions of Entry

The helm of the entered boat must be a member of the LCOA. If the helm is the owner of the entered boat he/she must be a full member of the association. If the helm is not the Owner, he/she must be full member of the LCOA if the owner is not a full member. If the owner is a full member, the helm must be at least an associate member. All crews must be at least associate members of the LCOA.

The safety of a boat and her entire management including insurance shall be the sole responsibility of the owner/competitor racing the boat, who must ensure that the boat and crew are adequate to face the conditions that may arise in the course of the race. Neither the sailing instructions, nor the inspection of the boat limits or reduces the absolute responsibility of the owner/competitor for his/her crew his/her boat and the management thereof. The race organizers shall not be responsible for any loss, damage, death or personal injury however caused to the owner/competitor, his skipper or crew as a result of their taking part in the race or races. Moreover, every owner/competitor warrants the suitability of his boat for the race or races.

Declaration

I agree to be bound by the Racing Rules of Sailing, and by all other rules governing this event. I undertake to sail in compliance with the RYA Racing Charter. I confirm that the above Boat and Helm have insurance cover to Third Party of £2,000,000 and I confirm that I have read and accept the sailing instructions. I have a valid measurement certificate available on the LCOA records for this year.

Before racing, I will ensure my crew is aware of the undertaking in this declaration, the importance of effecting appropriate personal insurance, and their responsibility in rules observance, in particular wearing personal buoyancy.
